

ORDINANCE NO. 2019-03

AN ORDINANCE ESTABLISHING RATES AND CHARGES FOR OWNERS OF PROPERTY SERVED BY THE TOWN OF DALEVILLE WATER UTILITY

WHEREAS, the Town of Daleville has constructed and operates a water utility for the purpose of providing water to the Town’s residents and businesses in a sanitary manner; and

WHEREAS, the Town has opted out of the jurisdiction of the Indiana Utility Regulatory Commission which controlled the rates and charges for the Town’s water utility; and

WHEREAS, it is necessary to establish a schedule of rates and charges to produce sufficient revenues to pay expenses for maintenance and operation of the water utility.

NOW THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DALEVILLE, INDIANA:

Section 1. There shall be and there are hereby established for the use of services rendered by the water utility of the Town of Daleville, the following rates and charges, based upon the use of water supplied by said waterworks system:

(a) Metered Consumption:

(b) Customer Charge:

All metered general water service customers shall pay a monthly Customer Charge based on the size of meter installed (or multiple meters installed—in which case, charges are based on the total of all installed meters). Monthly Customer Charges are listed below and do not include any allowance for water usage.
